This is why we volunteer our time to do this work, to connect our clients to employers, housing providers and educational institutions that see more than a criminal record. Despite the number of insurmountable barriers people with criminal records face, including those returning home from incarceration, we have found that with the services we provide, those we serve are bravely defying the odds by pursuing and securing a more prosperous future for themselves and their families.

Because we believe that equity and inclusion are the cornerstones of democracy and citizenship, we believe that EVERYONE needs and deserves equal access to the polls, employment, entrepreneurship, education, successful community integration other opportunities and pathways toward upward mobility. Multi-stakeholder partnerships are necessary to support those we serve to pursue such opportunities with persistence. Although we went another year not reaching our #dignityinhousing campaign goal of \$300,000 to start a housing program for formerly incarcerated men and women or get an office space, through your generous financial support last year, we achieved great milestones as we were able to expand our reach to more cities such as Sandy Springs, Albany and Dublin, GA where assisted justice-involved Georgians with non-rent housing related assistance (utilities), with fee assistance (IDs, birth certificates. bus passes and ride share rides), groceries, prescript and domestic violence support.

In 2024, we were able to reach over 2,000 people through voter education and engagement activities, hired canvassers and phone bankers through our work as a part of the HOAPE Coalition.

EQUIP

By providing our clients with the tools and skills needed to seek, obtain and maintain employment, housing and education and to become civically engaged, they are placed in a better position to be successful.

By achieving equity, power and upward economic mobility, they are less likely to re-offend to support themselves and their families and instead are more likely to become more successful, self-sufficient, socially engaged and contributing members of their communities.

EMPOWER

When equipped with the skills, tools, mentorship and support they need to become self-sufficient, those we serve become empowered and confident in their ability to become successful in their reentry.

RESTORE

When self-sufficient and successful, those we serve are restored to law abiding and productive members within their communities.

Expanded Our Reach & Impact

Although we stopped sending out resources via email in November 2024, our emails were received by over 1,200 individuals in Georgia (and Alabama) who are impacted by a criminal conviction or are loved ones of justice impacted people, resource providers, jail & prison staff, probation & parole officers, educational institutions, landlords, employers, transitional housing providers and legal representatives.


2024 Financials

2024 RECAP & HIGHLIGHTS

1 RECEIVED A NEW GRANT

October- We received a \$5,000 grant from Fair Count to conduct Get Out the Vote and Voter Engagement Activities throughout Georgia.

2 AMPLIFIED REENTRY AWARENESS-RECEIVED PROCLAMATON FROM GOVERNOR FOR 8TH YEAR

For the 8th year, we received a proclamation from the Governor to observe July as Reentry Awareness Month throughout the State. We hosted nine events, co-hosted three events and tabled at three events that educated the community on the barriers of reentry, entrepreneurship as a viable pathway to success, the challenges of reentry for special populations (elders, trans, people with mental illness or substance dependence and those on the sex registry), voting rights and procedures for trans Georgians and those impacted by a felony, inspirational panels and hosted 3 in person FIP only fellowship, networking and restorative justice circle dinners.

JOINED THE NATIONAL ASSOCIATION OF REENTRY PROFESSIONALS (NARP)

In 2024, we joined the National Association of Reentry Professionals, a national network of skilled reentry advocates that represent the interests of criminal justice professionals engaged in prison reentry, people who have been incarcerated and their family members, and other justice reform advocates, that provides education, training, and professional services.

5 WELCOMED 2 NEW BOARD DIRECTORS

In 2024, we welcomed 2 new board directors, Irma Mason and Juanisha Byrd, both of Columbus, GA. Irma is a retired Air Force & Army Veteran and Federal Human Resources Specialist. She is the Co-chair of the Social Action/Political Awareness and Involvement Committee of the Columbus (GA) Metropolitan Alumnae Chapter of Delta Sigma Theta Sorority, Inc.

Juanisha is a public health, social justice and real estate professional who is the Co-Founder of Prime Properties Investment Solutions where she focuses on creating sustainable, community-centered housing that aligns with a commitment to equitable housing solutions. She also provides technical assistance to states and policymakers, leveraging data to reduce criminal justice spending and supporting advancements in state-level criminal justice policy. Prior experience includes leading initiatives aimed at transforming public safety.

2025 GOALS

1 SECURE FUNDING TO SUPPORT OPERATIONS, INFRASTRUCTURE AND HIRE AN EXECUTIVE DIRECTOR

This organization was founded in 2012 by Waleisah Wilson, after her release from prison to support others living with the challenges or navigating their reentry with a felony conviction. Since its founding, the organization has been led by Waleisah and others who have volunteered their time and personal finances to run the organization, oversee programs and provide its services. Therefore, securing funding to support the hiring of an executive director and support staff is critical to avoid burning out volunteers who have committed themselves to our mission for over a decade and thereby ensuring the future growth and success of the organization.

We have missed out on several opportunities such as grants and collaborative partnerships due to not having a physical office space. Therefore, obtaining an office space in Columbus as well as in either Atlanta, Douglasville, Hiram, Villa Rica, Sandy Springs, Lithia Springs or Marietta is vital to our expansion goals.

2 START PROGRAMS FOR JUSTICE-INVOLVED WOMEN & GIRLS (LEADERSHIP & ENTREPRENEURSHIP)

It is our hope to start an intensive 2 phased virtual 10 week paid online leadership training program for justice involved and formerly incarcerated women and girls (including trans women and girls) as well as an 8 wk entrepreneurship course for women & girls.

3 START A READING & LITERACY INTERVENTION PROGRAM & DIGITAL SKILLS TRAINING PROGRAM

According to the National Adult Literacy Survey, 70% of all incarcerated adults cannot read at a fourth-grade level, lacking the reading skills needed to navigate many everyday tasks or hold down anything but lower paying jobs. Data supports that those without sufficient income earned by work are the most prone to committing a crime to support themselves.

Because reading is a powerful transformative tool for personal development, increased self-knowledge and self-understanding that can help currently and formerly incarcerated people change their values, beliefs and behaviors, it is our goal to develop and start an adaptive literacy program that will develop the comprehension, proficiency and motivation of the students so they may become successful readers and in turn become more successful in their reentry.

4 PRIORITIZE REENTRY, ADVOCACY AND EDUCATION

Although we have been great at the work we do to find and share background friendly resources and connect our clients to employment and housing, we have come to realize that our work and energy needs to be prioritized on actively creating the change we seek by being more involved in advocacy (to support actions that will change the criminal legal system as a whole) and focusing on providing training to our clients have the skills and tools needed to navigate our virtual world and to BECOME the boss! Therefore, stay tuned to the new programs to come in 2025!
